# ROLE OF THE SPVM IN SEXUAL ASSAULT AND SEXUAL DELINQUENCY



The mandate of the *Équipe des agressions sexuelles* is to solve investigations relating to sexual assaults committed in the Montréal area.

The mandate of the *Équipe de surveillance des délinquants sexuels* is to monitor sex offenders and register them annually with the National Sex Offender Registry when required by law.



## WHAT IS A SEXUAL OFFENCE?

**Sexual assault** is a sexual gesture committed by a person towards another person, without the latter's consent.

There are other sexual offences such as, for example, indecent acts, voyeurism and exposure. These offences do not constitute sexual assault.

Sexual offences are crimes.

#### EXAMPLES OF SEXUAL OFFENCES PROHIBITED BY LAW:

Grabbing, groping, smacking or touching someone's private parts without their consent.

Kissing another person without their consent.

Showing your genital organs or masturbating in public in front of someone.

Spying on someone in their private life or trying to see someone's private parts, bottom or breasts.

Access, possess, make or distribute child pornography.

# CONSENT

Consent is the voluntary agreement between partners to participate in a sexual activity.

#### Free

You are the only person who can decide whether to consent or not. Your consent is not free if another person puts pressure on you, insists, threatens you or uses force.

# Informed

You should know exactly what is going to happen and what you agree to take part in. Your consent is only valid for the activity to which you consent at a given moment.

#### Reversible

You can change your mind at any moment and your choice should be respected.

#### Enthusiastic

You should be fully in agreement and at ease with what you are being proposed.

# EXAMPLES OF CIRCUMSTANCES WHERE CONSENT IS NOT VALID:

- O The person is intoxicated (alcohol, drugs).
- O The person is unconscious or sleeping.
- O The person has changed their mind, shows discomfort or says no.
- O The person has not clearly indicated their consent, through their gestures or words.
- A person uses manipulation, blackmail or threats.

The prevention of sexual violence inevitably involves education in **healthy**, **egalitarian relations** between people.

Silence or lack of refusal is not consent.

Consent cannot be obtained if the aggressor abuses a position of trust, power or authority.

# NATIONAL SEX OFFENDER REGISTRY

If you are found guilty of a sexual offence, you may be liable to imprisonment. In addition, as a convicted sex offender, you may be subject to obligations under the *Sex Offender Information Registration Act.* You may be required to register annually with the National Sex Offender Registry.

The Criminal Code defines the designated sexual offences for which an order to register with the National Sex Offender Registry may be issued by a judge, including:

# Sexual interference | Invitation to sexual touching

Sexual exploitation | Bestiality

Child pornography | Exposure

Sexual assault | Incest

Sexual assault with a weapon | Luring a child

Aggravated sexual assault

The National Sex Offender Registry is used to help police services prevent and investigate crimes of a sexual nature, while respecting the Canadian Charter of Rights and Freedoms. (Source: justice.gc.ca.)

If your home address is located outside Montréal, contact Sûreté du Québec at 1 866 958-4636.
